Mayfield 7 Berth Schedule of Charges

This Schedule of Service Charges for Stolthaven Australia Pty Ltd (ACN 075 030 992) is a summary of the Service Charges applicable for the commercial use of Mayfield 7 Berth for the period from 1st July 2026.

All charges in this schedule are in Australian dollars and are exclusive of GST. The party liable for the Service Charge is identified in the relevant provisions the Act and Stolthaven may in its discretion, agree to issue invoices to shipping agents engaged by a person who is liable to pay any Service Charge.

This Schedule is a summary of the charges applicable to the use of the Mayfield 7 berth. It does not contain all the terms and conditions applicable to the charges, use of the Mayfield 7 Berth or the Port of Newcastle. By using Mayfield 7 Berth you agree to be bound by the terms and conditions in this Schedule and all other relevant Stolthaven requirements.

Service Charges

Wharfage

The Wharfage Charge is charges per Revenue Tonne for all import or export of product. A Revenue Tonne is the greater of mass or volume of the cargo measured in units of tonnes, cubic meters or kiloliters.

Charge	Basis	Rate excluding GST
Wharfage	Revenue Tonne	\$3.77

- *Vessel outturn must be provided following completion of discharge.*

Occupancy Charge

The Occupancy Charge is a time based charge for use of the Mayfield 7 Berth. The Occupancy Charge is payable for the time a vessel is alongside the berth commencing from tie up of the vessel until departure from the berth.

Charge	Basis	Rate excluding GST
Occupancy	Hourly (or part thereof)	\$375.00

- *Site occupation charges are calculated per hour with part-hours rounded up to the next whole hour.*

Labour Charge

Labour for attending the ship discharge and/or providing services on request.

Charge	Basis	Rate excluding GST
Labour	Per hour	\$180.00

- *The Labour Charge may not be applicable if the services are charged or provided under another agreement between Stolthaven Australia Pty Ltd and the product owner.*
- *Minimum 4 hourly charges apply.*
- *Cancellation or standdown fees may apply in the event of changes to shipping arrival times made after business hours or with late notice.*

Security

Security on Mayfield Berth 7 during the discharging or loading of vessels.

Charge	Basis	Rate excluding GST
Security	Per hour	\$75.00

- *The Labour Charge may not be applicable if the services are charged or provided under another agreement between Stolthaven Australia Pty Ltd and the product owner.*
- *Minimum 4 hourly charges apply.*
- *Cancellation or standdown fees may apply in the event of changes to shipping arrival times made after business hours or with late notice.*

Terms of Trade

Stolthaven's terms of trade require that payment is made within 14 days of the date of the invoice.
